1. LICENCE AGREEMENT

- 1.1 By installing this software product ("CASPA") or using any of the associated materials or documentation supplied with it, you ("the Licensee") agree to the terms and conditions of this licence agreement.
- 1.2 The Licensor is SGA Systems Limited. The Licensor is a company registered in England and Wales under number 6299390 whose registered office is at 210 Palamos House, 66-67 High Street, Lyngington SO41 9AL
- 1.3 The Distributor is the National Association of Independent Schools and Non-maintained Special Schools (NASS). The Distributor is a Registered Charity No: 1083632 and a Company Limited by Guarantee registered in England and Wales under number 3774801 whose registered office is at Hollybank Trust, Far Common Lane, Mirfield, West Yorkshire, WF14 0DQ.
- 1.4 The Licensee is a single educational establishment that is a member of NASS (National Association of Independent Schools and Non-Maintained Special Schools) directly or covered by Group membership of NASS. Organisational members of NASS who purchase software for two or more of their schools will have the option of receiving the Local Authority module (at no additional cost), which will allow them to make comparisons between their schools.

2. LICENCE TERMS APPLICABLE TO USE AND DISTRIBUTION

- 2.1 This software product is supplied under licence for use within a single educational and/or administrative establishment maintained by the Distributor.
- 2.2 The licence is valid for one year from the date purchased, renewable annually and valid only if the Licensee remains a member of NASS.



- 2.3 Under the terms of this licence:
- 2.3.1 the Licensee may install the software on as many computers as are required at the site belonging to the licensed school or establishment, including laptop computers used in connection with the business of the same;
 - 2.3.2 any installation as described above can be used by any employee or agent of the Licensee;
 - 2.3.3 the Licensee may make read-only (i.e. 'GUEST') installations of this software product available to any third party who has a bona fide relationship with any educational or administrative establishment maintained by the licensee, e.g. School Improvement Partners not directly employed by the Licensee.
- 2.4 Other than as described above, this software may not be distributed to any third party under any circumstances without the express permission of the Licensor.
- 2.5 All rights not expressly granted here are reserved to the Licensor. The use of this product is expressly prohibited except as authorised by the terms of this agreement. Copyright, title, ownership rights, and intellectual property rights in and to this software product shall remain with the Licensor. No attempts may be made to decipher, de-compile, disassemble or reverse engineer the software product for any reason whatsoever.
- 2.6 Comparative data is based on the analysis of assessment results supplied by participating schools, Local Authorities and other educational organisations; to continue this spirit of mutual benefit, there is an expectation that all users of CASPA should make a return of anonymised data for inclusion in the annual analysis that results in updated comparative data.
- 2.7 Under the terms of this licence submissions of anonymised data will be to NASS towards the end of each summer term for a date identified by NASS using the supplied export feature of the software product.

3. WARRANTY

- 3.1 This software product is supplied "as is".
