What we do

NASS is a strong voice for the sector.

We have more than 450 member schools and organisations in our community, including **non-maintained special schools, independent special schools, special academies** and **multi-academy trusts** with special schools.

The team is also available to provide individual guidance to our members.

Leadership programmes and support

We help you develop and become centres of excellence through bespoke leadership programmes for special schools. Recent programmes have included NASS sponsored places on School Improvement Partner training, social care leadership and nurturing new heads. We also have a strong network of NASS SIPs that can offer their support to other NASS members.



Piloting innovation

We look for innovative ways to tackle issues that affect you by collaborating with partners and give you the opportunity to be part of this research. This year we are running an AI pilot programme for special schools involving 11 NASS members as well as a programme that addresses key challenges of attrition, retention and recruitment in schools.



Developing knowledge

We invest in initiatives that will provide long-term value for you. For example, we commissioned a report on the cost and value of meeting need for children and young people with SEND. We also sought legal advice to give you clarity on the setting and payment of fees and more recently around changes in procurement.

We take pride in sharing your excellence and best practice. We do this through recognising your work at our annual NASS Awards and using our social media channels and website to highlight the difference you are making throughout the year.

NASS operates a rolling membership. Six weeks before your renewal date, we will send you a reminder about your subscription and the applicable fees* for the coming year.

We offer a 50% discount on first-year membership fees** to all schools and organisations eligible to join NASS as full members. This introductory discount is designed to support new members as they settle in and start accessing our full range of benefits.

Full membership - individual and trusts/groups

Open to all fully registered, Non-Maintained Special Schools, Independent Special Schools, Special Academies (including converter and Special Free Schools) and Multi-Academy Trusts with special schools.

Full membership: Individual schools

NASS membership offers exceptional value, with fees tailored to the size of each school. Annual fees for individual schools are calculated on the number of pupils and staff. This can range from as little as £75 to just £223 per month. This ensures that schools of all sizes can access our full range of resources and support.

Full membership: Trusts and Groups

For Trusts and Groups, we calculate annual membership fees based on the number of schools within your organisation. This approach ensures we deliver the best value while providing comprehensive access to NASS resources and support across your network.

Discounted group membership is available to organisations with two or more schools eligible for full or associate membership. To qualify, all special schools within the organisation must become members.

Associate membership

Associate membership: Schools

Open to newly registered Independent Special Schools, Special Academies (including Special Free Schools) that have not yet received their first full Ofsted inspection.

Associate school members are expected to move to full membership status within one year of their first full Ofsted inspection, on the anniversary of joining date.
